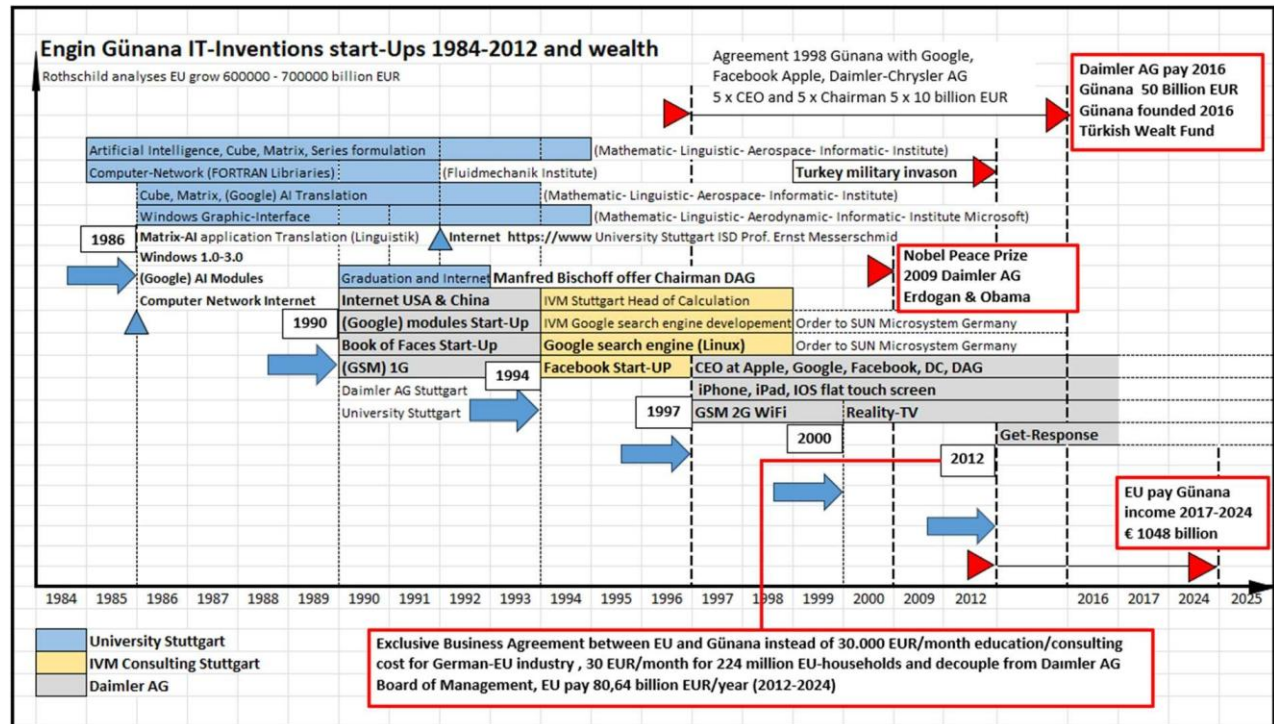

Die Personalien und die Staatsangehörigkeit der Antragsgegnerin wurden festgestellt.

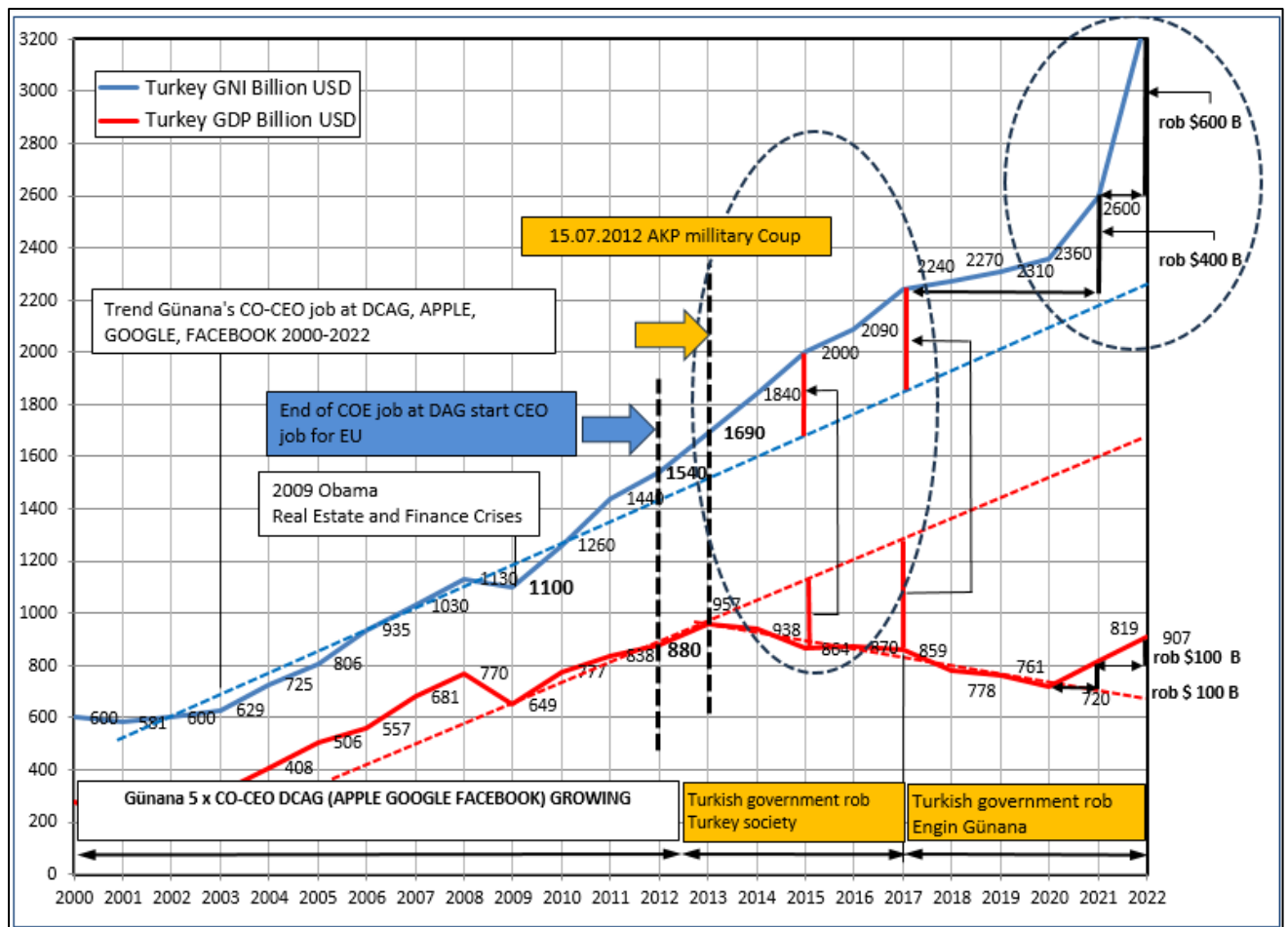

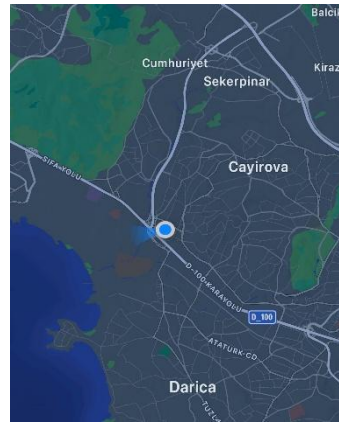
GNI from Turkey show Günana EU income and Turkish government robbery
