Time-Map of Dipl.-Ing. Engin Günana IT - Technology and IT Business

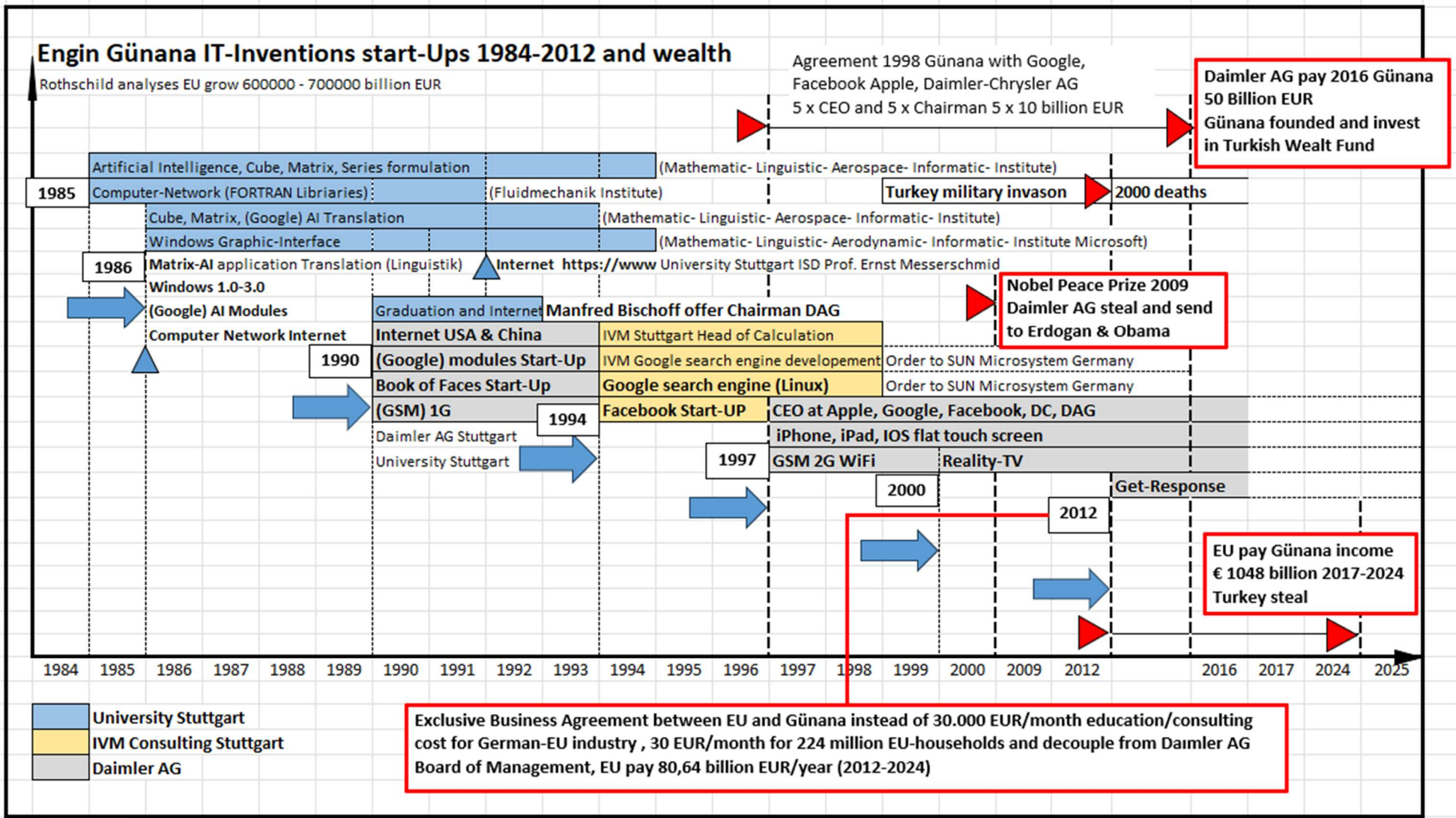


Chart 1: Timeline Dipl.-Ing, Engin Günana IT- Technology and System develop,per, 5 x times co-chairman and ceo at 5 companies

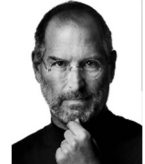

4,5 Contracts with encounter meetings are not valid, since 23.01.2016, since Dipl.-Ing. Engin Günana's went in pension with 50 billion EUR achieved in Turkish Wealth Fund, which was occupied from criminal and corrupt Turkish government in 2016.

4.6 Orthograph failure particular gaps or compromised parts of contract in contrary to contract target, can't change the basics and target of content to claim with lawsuits Dipl.-Ing. A further development of AI increase after higher physics at static and dynamic institute Stuttgart University we transform word-cells to word-elements and sentence-elements regarding Finite Element Method and mass, bar, triac3 and quad4 elements.

We build first sentence-elements with a rights system and coupled condition and increase our couple condition with spline curves for more complex and variable sentences. We stretched coupled sentence elements with splines curves stretch vector analysis orthogonal condition, accept 5-10° tolerance for sentence variants and approximate with iteration orthography rules to fulfill conditions of speech variability.

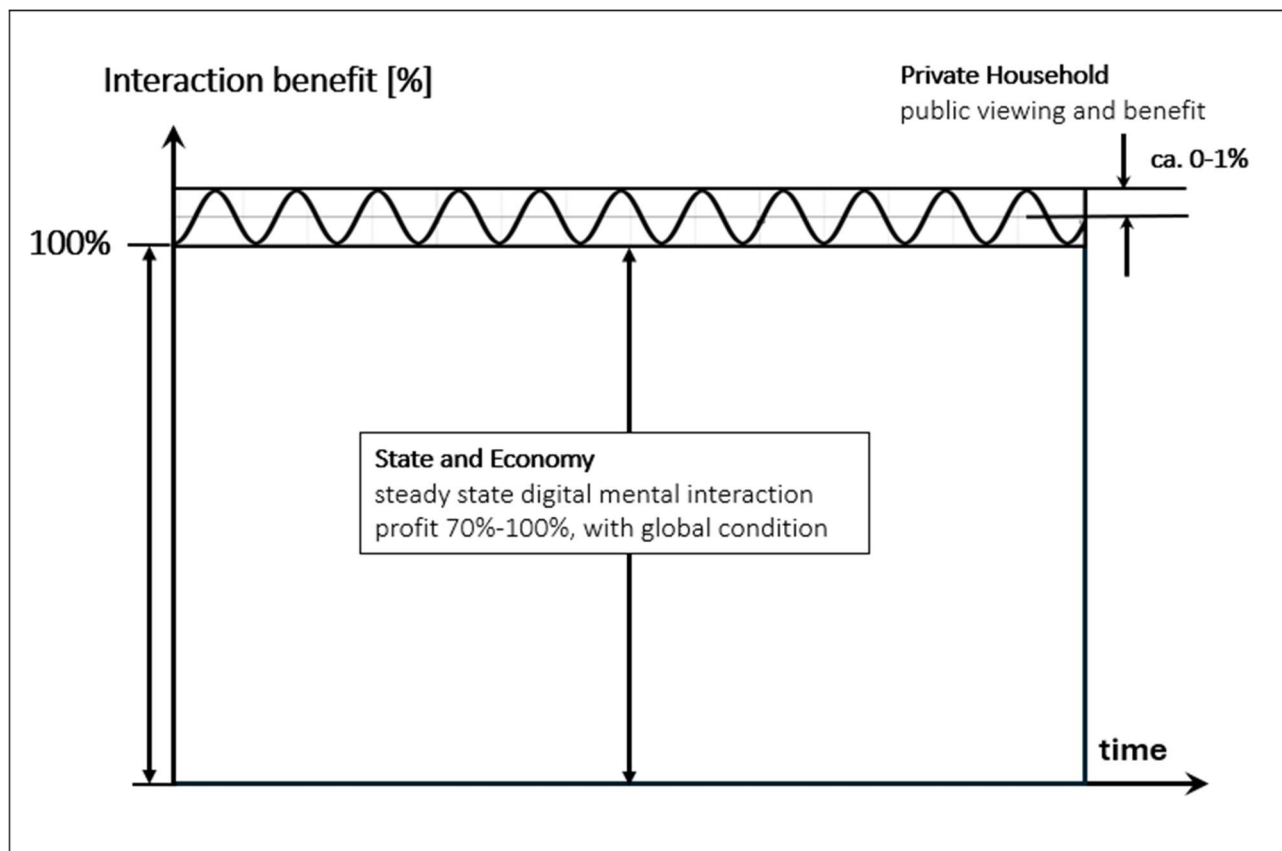

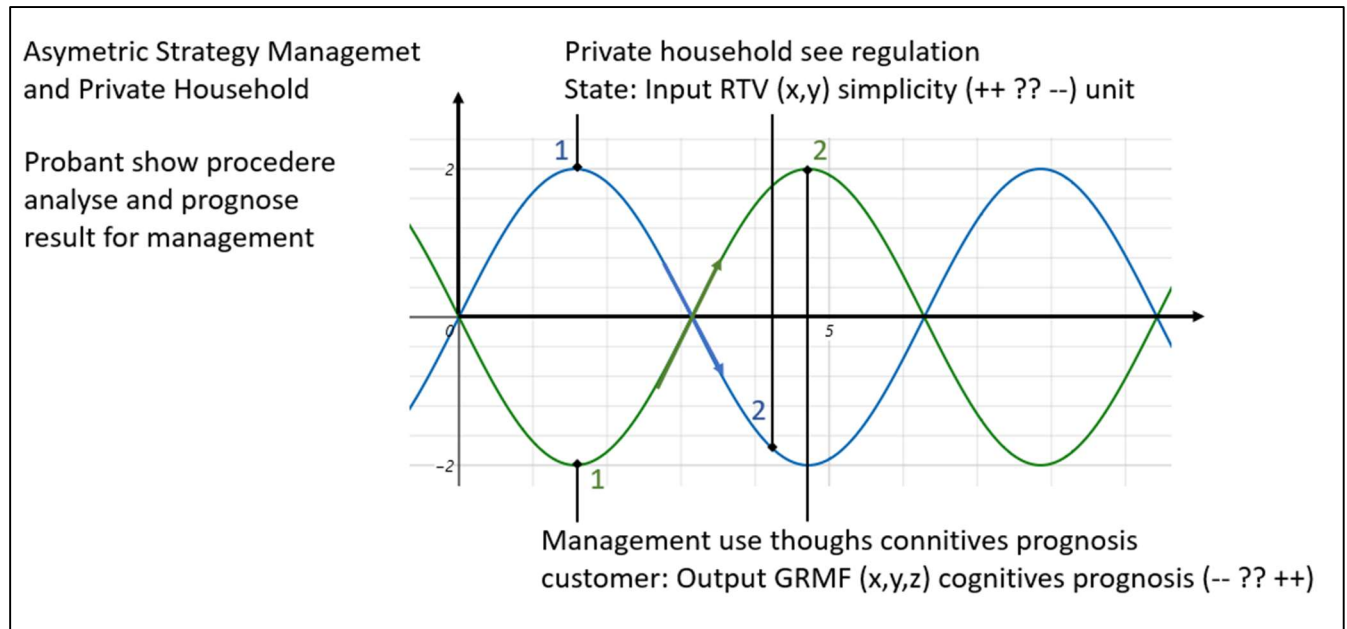


Chart 3: Example of expenditures optimization with disperse strategy tel. controlled from BND

Steve Jobs was the one face to customer project leader at Apple to us Daimler AG.

Dipl.-Ing. Engin Günana project team for iPhone and iPad development at Daimler AG: Dipl.-Ing. Klaus Hageman (secretary), Dipl.-Ing. Gerhard Spindler (extern) at Dr. Rolf Klumpp department EP/MPP Daimler AG. The iPhone cooperation starts with Apple Inc. and project leader Steve Jobs 1997 and end with Steve Jobs death in 2011. Dipl.-Ing. Engin Günana participation agreement at Apple Inc. was in a range 1% to 10% of Apple shares.

After Dipl.-Ing. Engin Günana first meeting with project leader Steve Jobs/Apple Inc. in Stuttgart, the product name of a multi device was set from Günana with 'iPhone', in acceptance from Apple Inc. chairman Michael Spindler the term 'smartphone' doesn't exist at this period

Dipl.-Ing. Engin Günana set product name iPhone and big brother iPad and development scope of multi device Engin Günana introduced the concept of a multi device phone, a combination and flat screen pocket phone and computer with a new finger and gesture-based operating system. A pocket phone with multi devices with contents of devices, which is necessary from chief engineers to businessman, a mixture of computer and phone in pocket format. Twelve and more devices in one device and give the product the name

iPhone. Participants of first meeting: Dipl.-Ing. Engin Günana, Dr. Rolf Klumpp, Steve Jobs Apple Inc., Klaus Hagemann (organization). The iPhone project started 1997 and end with death from Steve Jobs at end of 2011.

Dipl.-Ing. Engin Günana introduce 1992 the first frequency 1G independent from mobile phones for more capacity of digital network. The first digital mobile network standard 1 G was introduced from Dipl.-Ing. Engin Günana in common with Prof. Ernst Messerschmid at Space Technology Institute University Stuttgart

As evidence Günana choose the first character of the new standard with the first character of his last name **G**ünana with **G**. 1G was qualified as a new mobile standard but data flow was too slow and unusable for smartphone application after first prototypes iPhone 1 and Günana decided push mobile internet network to higher standards with higher data volume rates and introduce a further development GSM mobile network from 1G to 2G with 900 MHz / 1800 MHz frequency. The new GSM standard for mobile network was foundation and get the name **G**ünana **S**teve **M**erkel **GSM**.

Dipl.-Ing. Engin Günana set **M** as last character of GSM shortcut as appreciate to politician newcomer of Angela Merkel political careered Angela **M**erkel after German Union in 1990. The name convention of GSM was set with the first 3 characters of **G**ünana-**S**teve-**M**erkel sur and last names in 1997 as evidence of Dipl.-Ing. Engin Günana iPhone and mobile cellular **1G** foundation. Steve jobs partnership and evident Angela Merkel.

We pushed the second generation of cellular network with 2G and 3G to higher data rates for our iPhone and iPad development. The development time of iPhone was steered from mobile cellular network development and was too slow, therefore we used iPhone 1 in offices to check performance and capacity of iPhone IOS cellular network and flatscreen function, because of less dataflow of cellular network 2G.

During iPhone 1 and iPhone 2 development our challenge was to solve touch screen and higher network standard with higher data volumes requirements and conditions. A bottle throat was 2G GSM standard with too less data transfer capacity this requirement was our challenge to develop faster mobile network for less distance in offices and introduce a bridge solution with wireless connection and called Lan a Turkish civilian rephrase for man in combination for industrial application for Germany and Europe WLAN and separate US American standard in agreement with Steve Jobs Wi-Fi and called my bridge solution standard IEEE 802.11x, with the name convention regarding iPhone notation i and Phone to iPhone, I as appreciate and evidence for

It was necessary to define frequency range for civilian application with civilian requirements and conditions to separate from military application. We started in Germany with 900 MHz / 1800 MHz and called our frequency range GSM regarding development project leaders name **G** for **G**ünana, **S** for **S**teve as partner and with **M** for former newcomer Angela **M**erkel after German Union 1990. GSM standard content the name of founder Günana-Steve and as appreciate Merkel German military was involved to separate civilian frequency range from military frequency range with different civilian requirements and conditions with **GSM** and called standard as military frequency area.

One of the biggest challenges was the cellular network and a finger and gestures based IOS with flat screen first iPhone 1 had a central button with backspace and cursor functionality and was not usable with bimetal contact technology at screen, multi-layer technology. Dipl.-Ing. Engin Günana decided to develop a mobile cellular mobile network for offices with for short distance and development WLAN and Wi-Fi. Wlan for German region and Wi-Fi for US region with the standard name convention IEEE 802.11x.

Higher and faster data rates with office cellular network was our next step and we developed Wi-Fi IEEE 802.11x standard. iPhone 1 - iPhone 2 were developed as prototypes for test phases in offices with Wlan IEEE 802.11x. We pushed one development step to another but without any compromises, a further development

iPhone display with multilayer technology according to AutoCAD design program and very effective finger and gesture based IOS at little iPhone display solve our challenges.

The first iPhone 1 with 2G cellular network didn't correspond to my expectations. We solved big challenges, touch screen functionality, dimensions, packaging, quality, faster mobile cellular network with higher data rates. We solved step by step all challenges and want the best at market in all disciplines.

A closed operating system 'IOS' with an application collection in store, apple specifics interfaces and a default scope of application for higher application engineers, chief engineers and managers. Daimler AG prevents internal application of iPhone with regulation for camera and distributes employee mobile phones with tel. and SMS functionality and closed camera function. Our greatest challenge was a sensitive multi touch screen and higher data volume. We stopped the delivery to customers and rolled out iPhone 1 to determined offices to evaluate our new WLAN and Wi-Fi Standard.

I arranged with Steve Jobs name convention for German, EU and USA with Wlan and Wi-Fi with a new standard. After evaluation of WLAN (Wi-Fi) standard with iPhone 1 and iPhone 2, we called our new mobile funk standard for offices and home offices IEEE 802.11x standard, a furthermore development of IOS with multifunctional touchscreen ability, prototype rollout of iPhone 1 and iPhone 2 in offices with Wlan devices for field test. iPhone 1 and IOS started with 2 main functions, open app with touch at app symbol at flat screen, steer with central button at bottom with curser function and return and backspace function to close apps. Stripe function we get later with iPhone 2 and IOS version. After our test with Wi-Fi which fulfils the higher data transfer rates our goal was a better functionality at touch screen display.

We decided to distribute as iPhone 4 slow Internet at field was our greatest challenge, we solved this internal with Wlan and Wi-Fi standard IEEE 802.11x coupled with much better functionality of new touch screen display function, which get a very complicated mesh layer technology during regular consultations at University Stuttgart with CAD and IT experts at display to consider finger stripes on flat screen, this function and more functionality we get with iPhone 4 with new application scope: Messages, Phone, E-Mail, Schedule, Calculator, Navigation, Maps, Camera, Video, Voice Recorder, Video Recorder, Video Player, Music Player and Music Channel (YouTube), Social Media and Facebook. Furthermore, we developed and considered data transfer standards Airdrop and Bluetooth. Responsible for distribution stop of iPhone 3G, development Wi-Fi, further development IOS functionality with more functions in combination with new flat touch screen display technology, data transfer technology Bluetooth and Airdrop, more application with more apps inclusive YouTube and social media was exclusively my content, without any support from Apple Inc.

Turkish national government with support German national government start an extortion and death program to steal IT-Founder of and destroy to Engin Günana co-chairman function and career with support from National Intelligent Agency MIT and BND, in contrary to agreement finally of course after Belin and Daimler AG AKP founder of in 14.08.2001 the real reason of AKP founder of with the target of industry crime from Turkish government to steal and sold Günana IT founder of Cube AI, Internet, GSM, Google, iPhone and Wi-Fi.

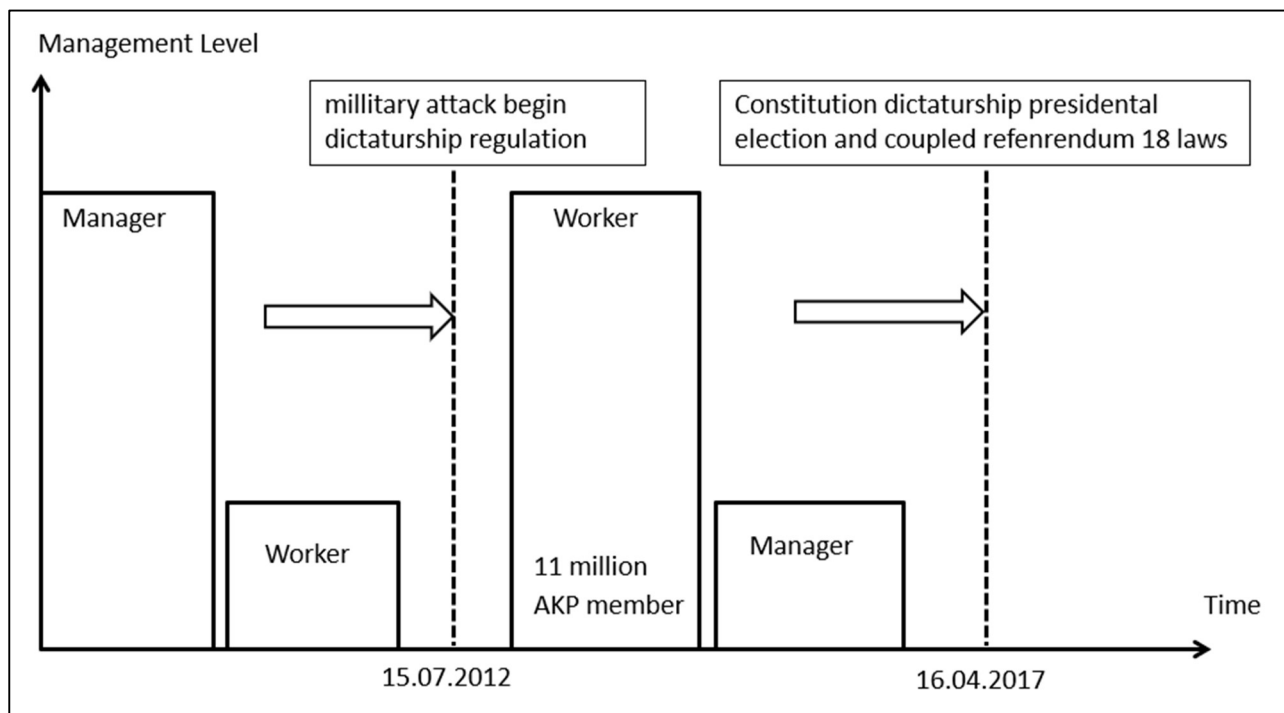


Chart 5.1: Replacement of millions of managers with AKP workers, soldiers and commissioner

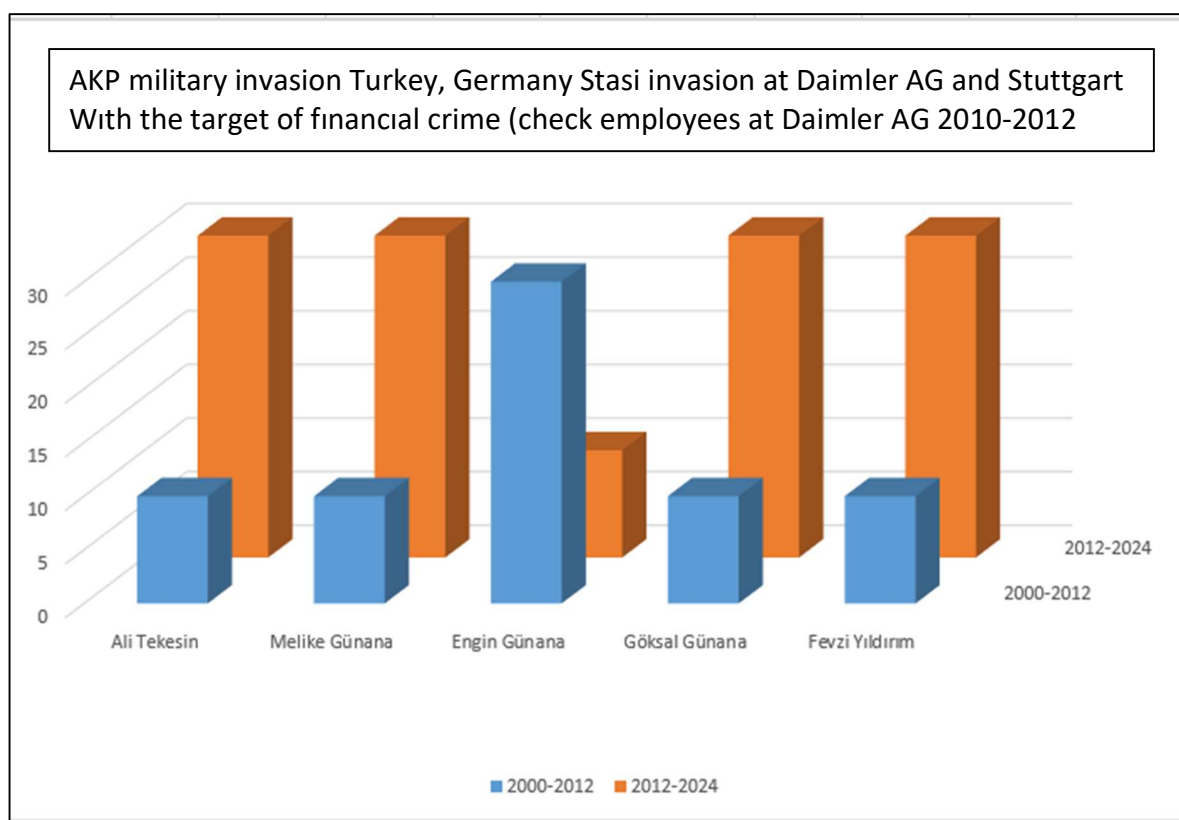


Chart 5.2. Reality 1984-2012 and Political Polemic Campagne 2012-2024

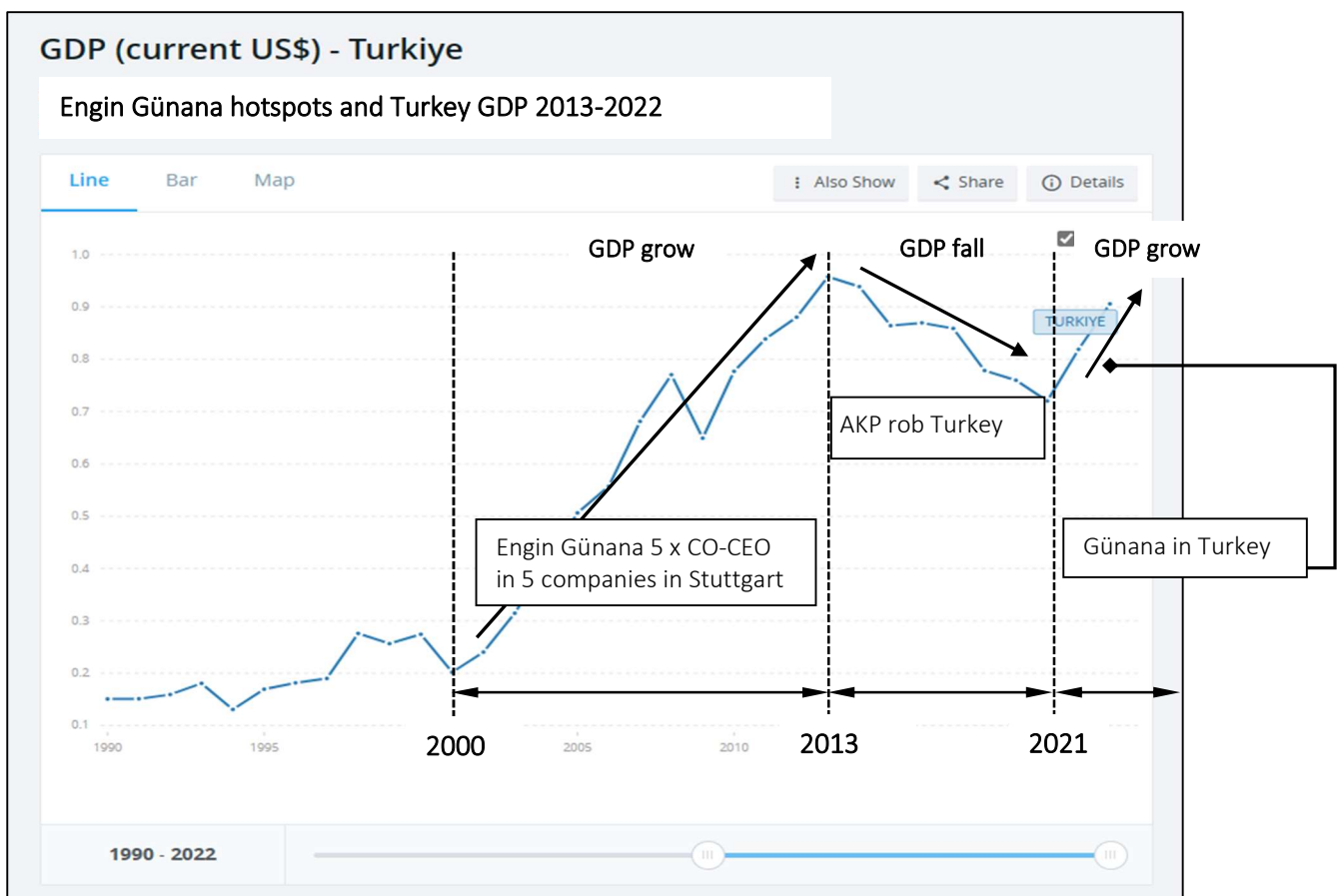


Chart 6: Turkey GDP 2000-2023 <https://www.data.worldbank.org>

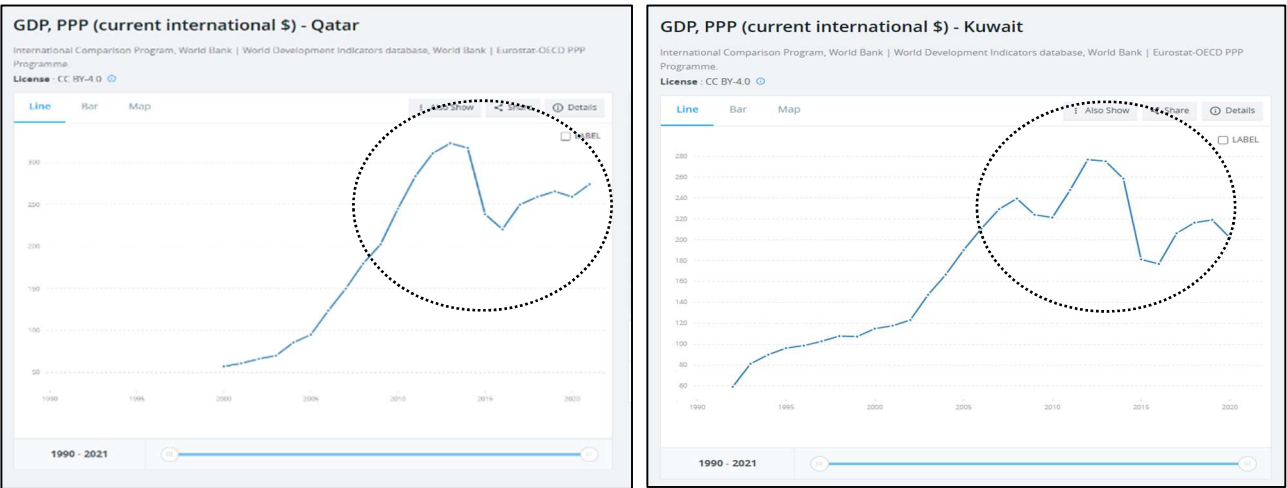

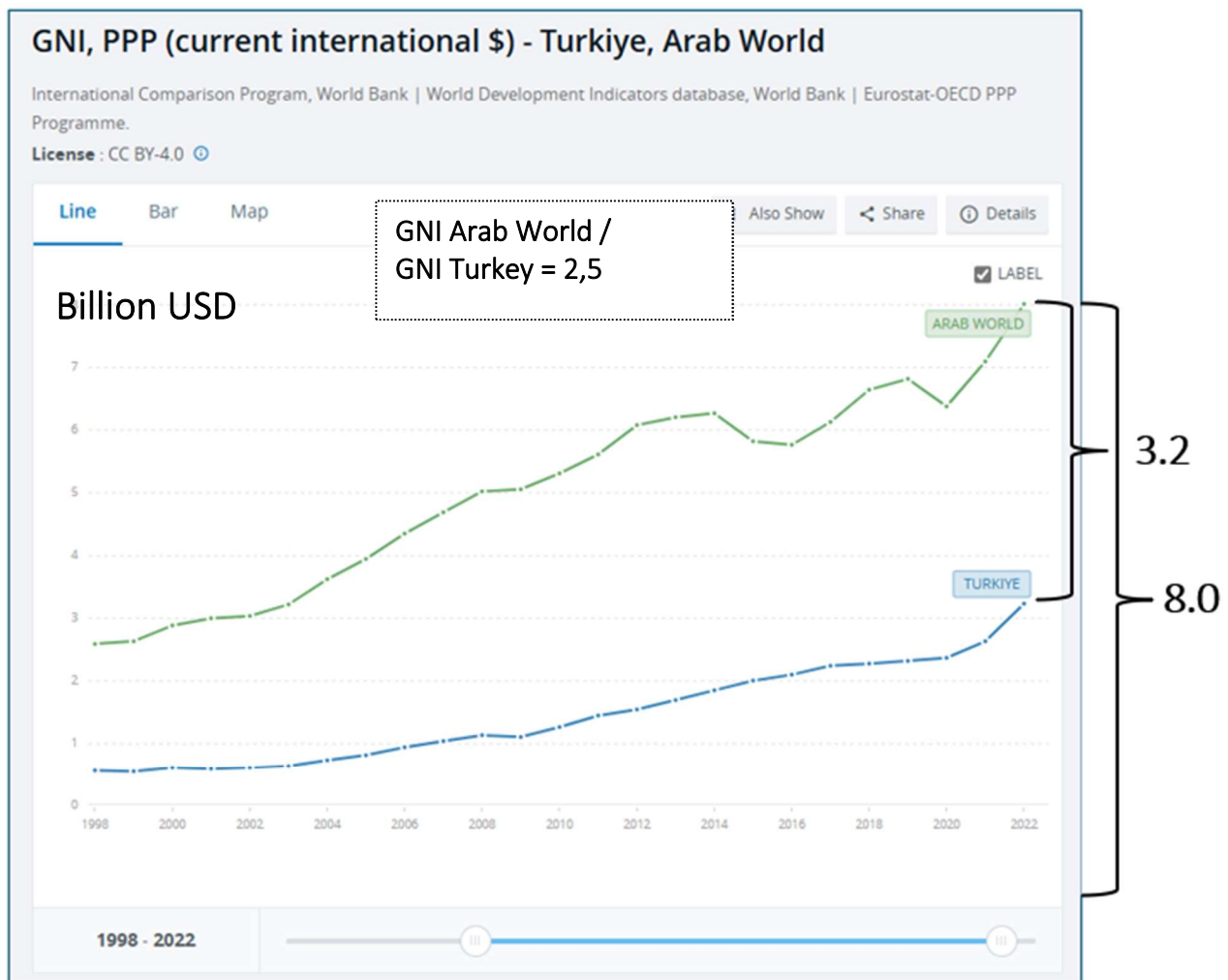


Chart: 8: GNI parity Arap World/Turkey and mutual financial dependence

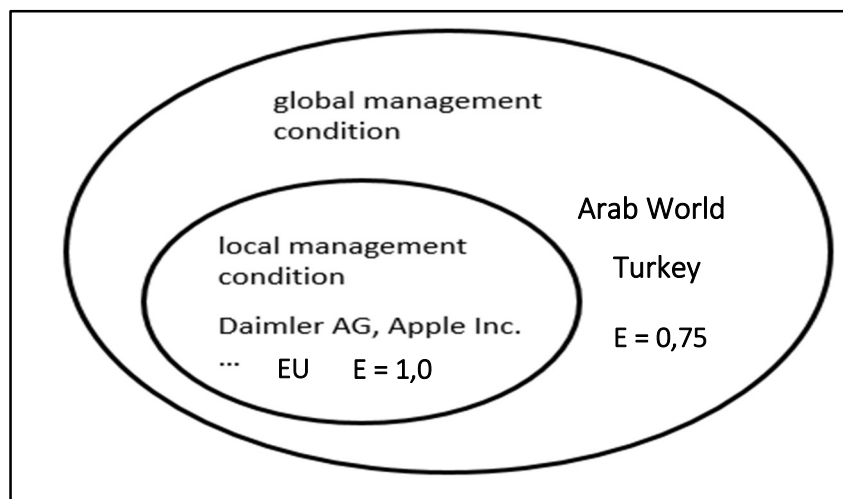

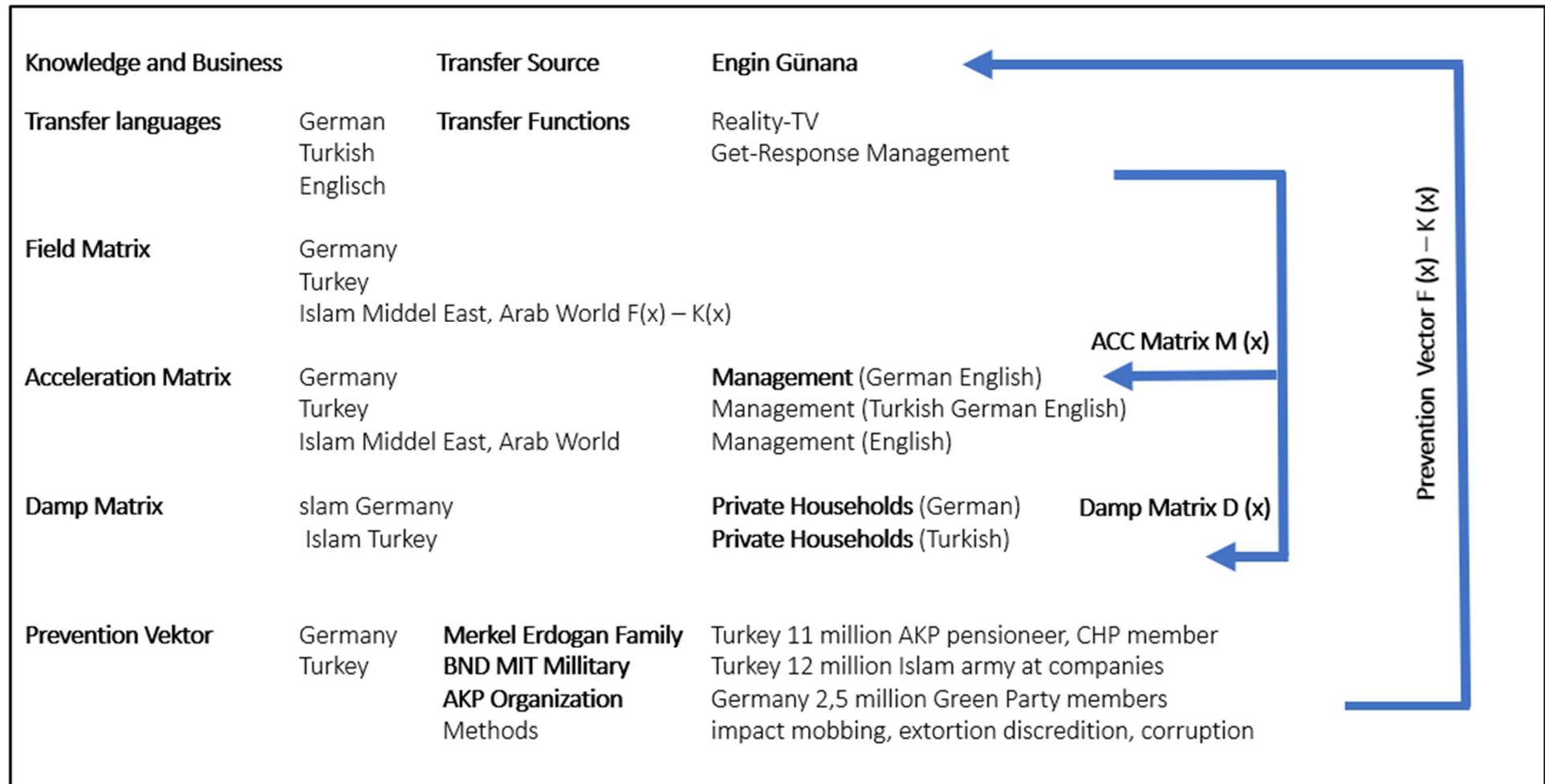


Chart 10: Industry Spying and Financial Corruption

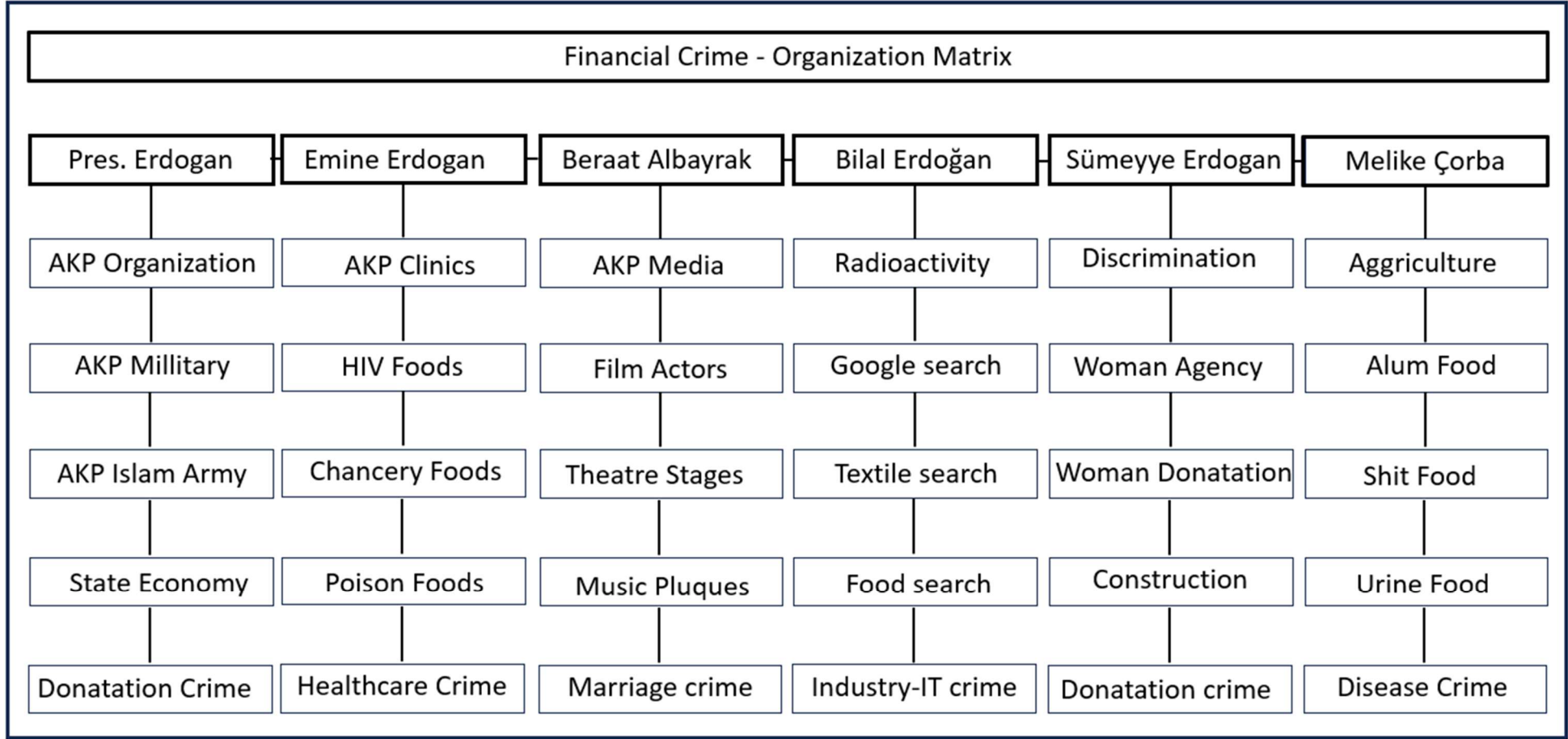


Chart 11: Industry Spying and Financial Corruption – Organization Matrix

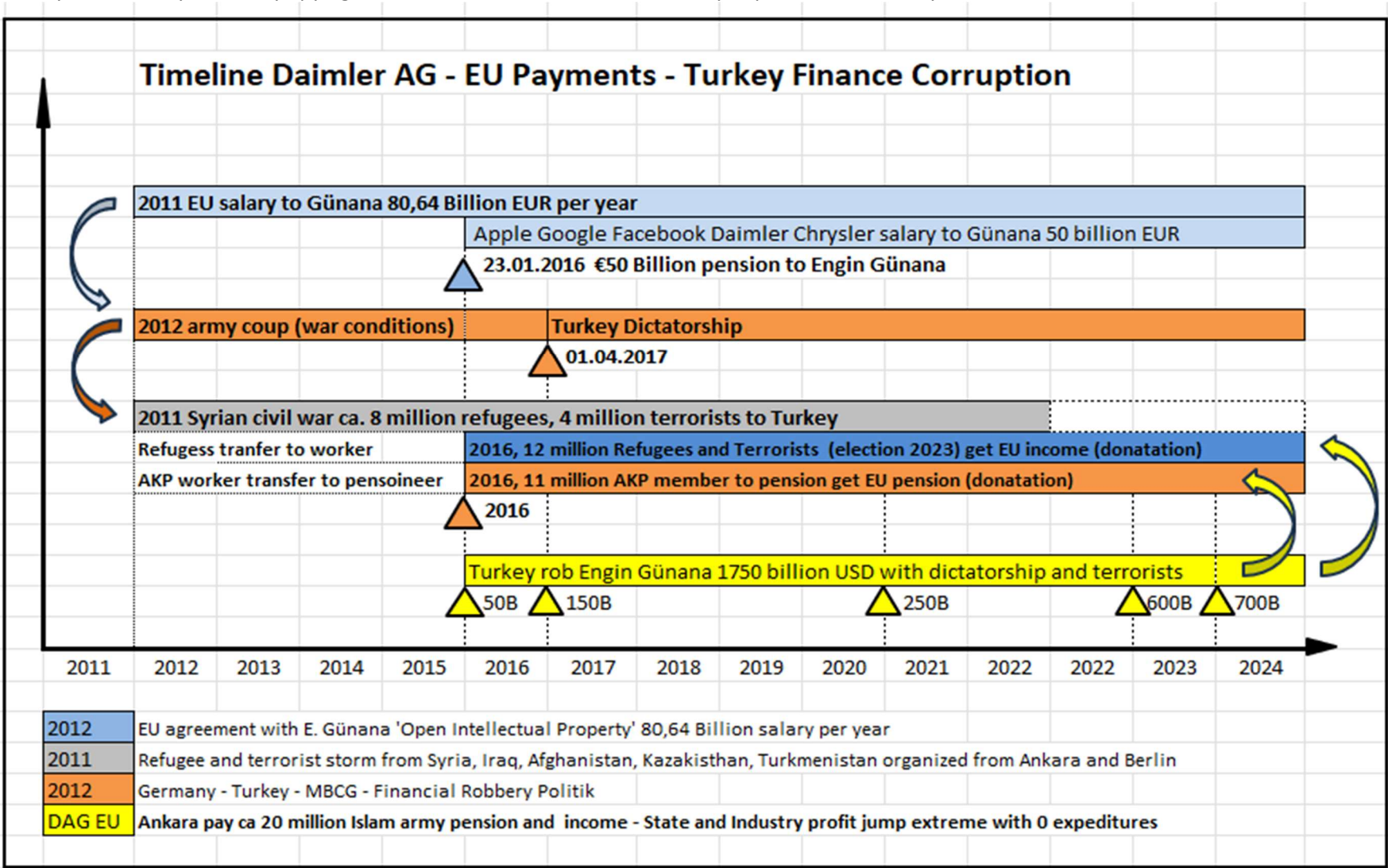


Chart 12: Industry Spying and Financial Crime Timeline

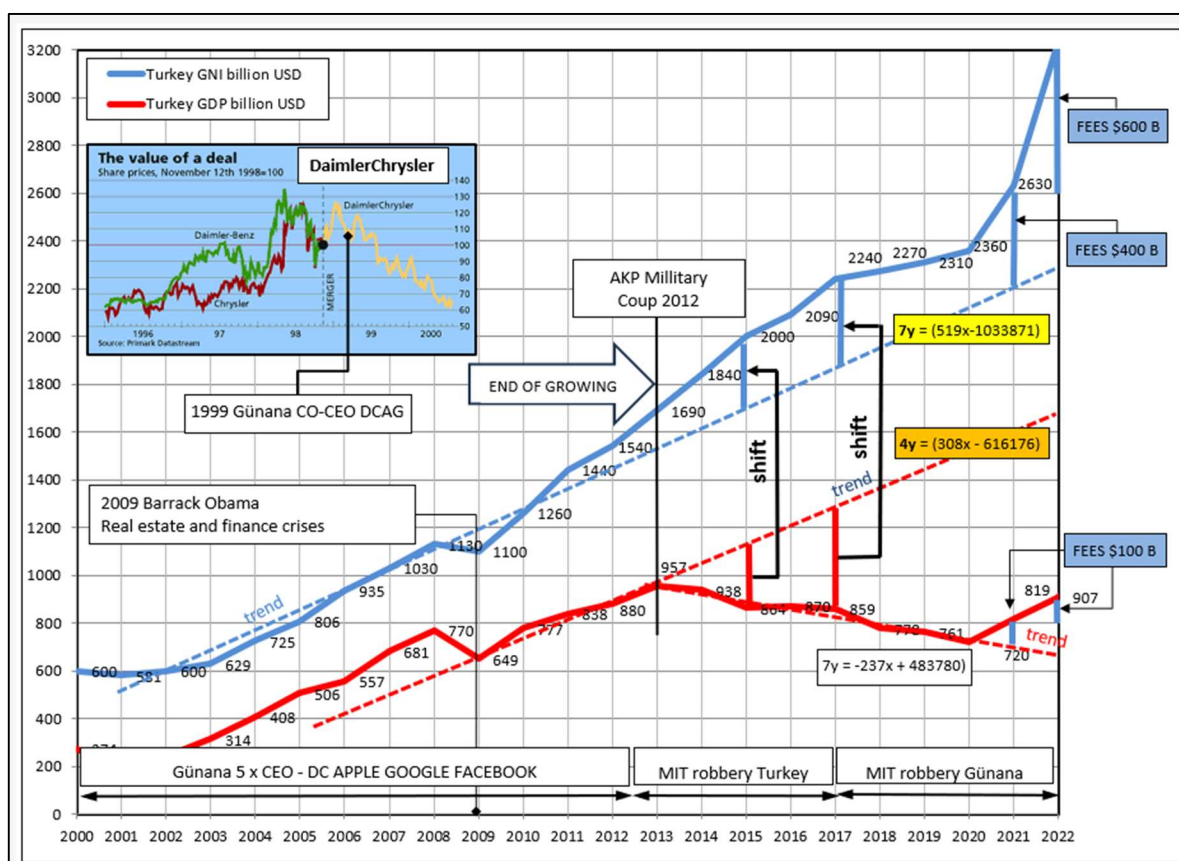


Chart 13: State and Economy Finance Robbery 2012-2022 over 2000 billion USD

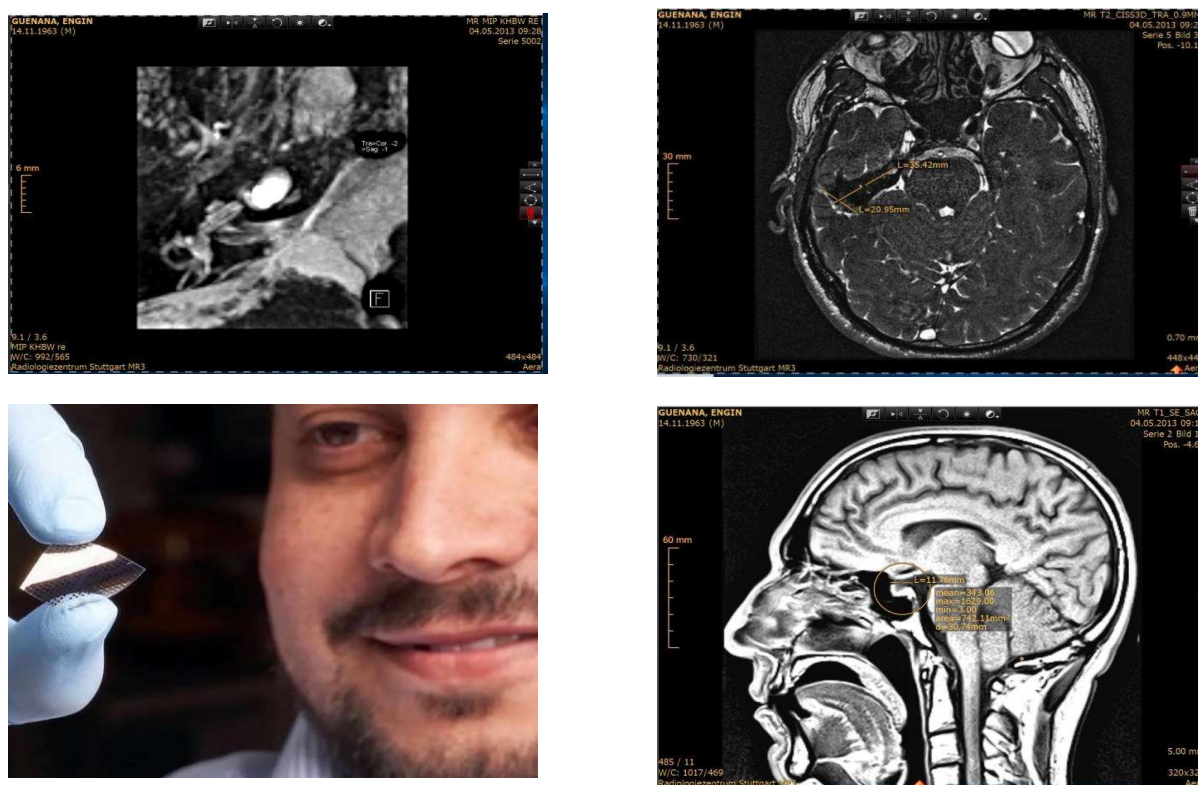

The Internet was a furthermore consequence founder of local specific Fortran IV program libraries. Institute had different specific local Fortran IV program libraries accordingly specific disciplines. Fluid mechanic Mathematic Informatic and Aerodynamic Institute had different Fortran Libraries. We increase local Fortran IV program libraries to global Fortran IV program libraries. We connect step by step computers of University Stuttgart, computers of Universities in Germany, calculation centers with cray computers and finally Daimler AG computer with NASA USA 1992 and introduce 1991/1992 1-GSM at Daimler AG (German military was interest) and Space Shuttle Institute IRS Stuttgart-Vaihingen to Prof. Messerschmid. developed UNIX OS to separate data to group in user/group/all and share over Atlantic with NASA. 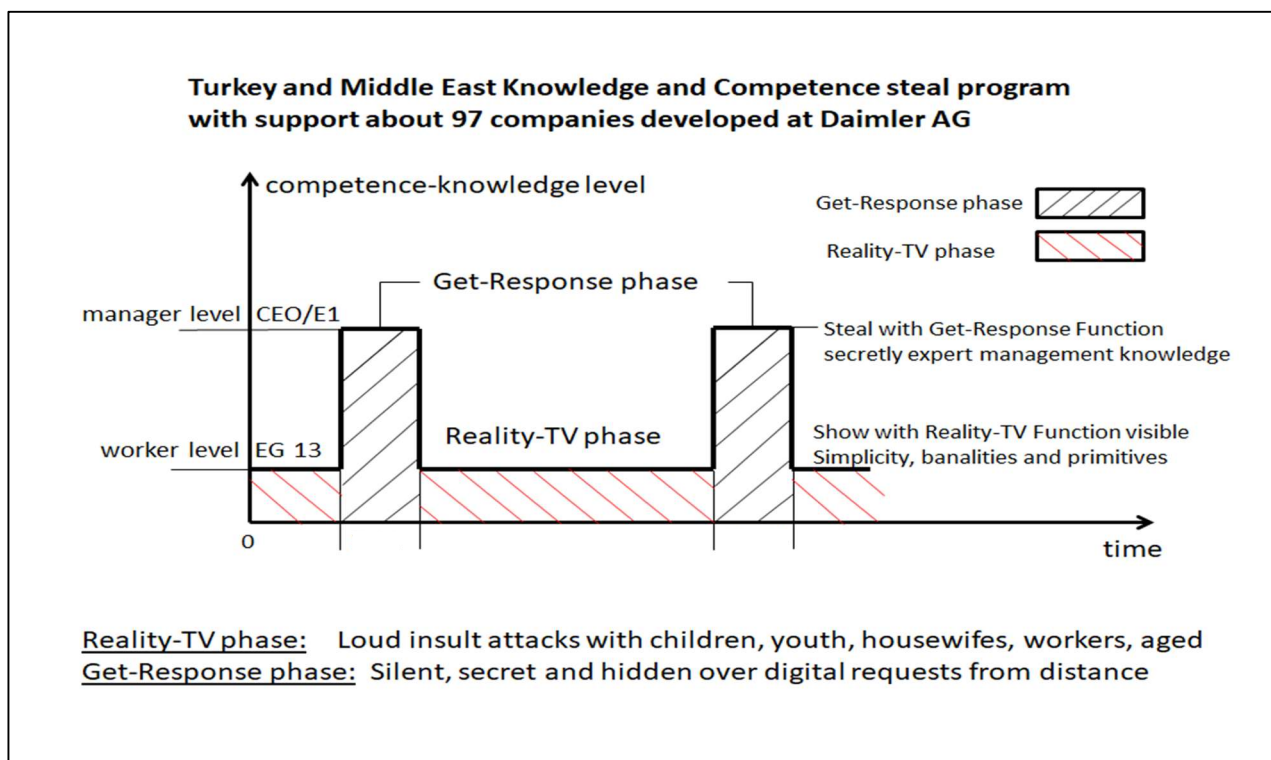


Chart 16: Symmetric/antisymmetric spying phases, time units are variable

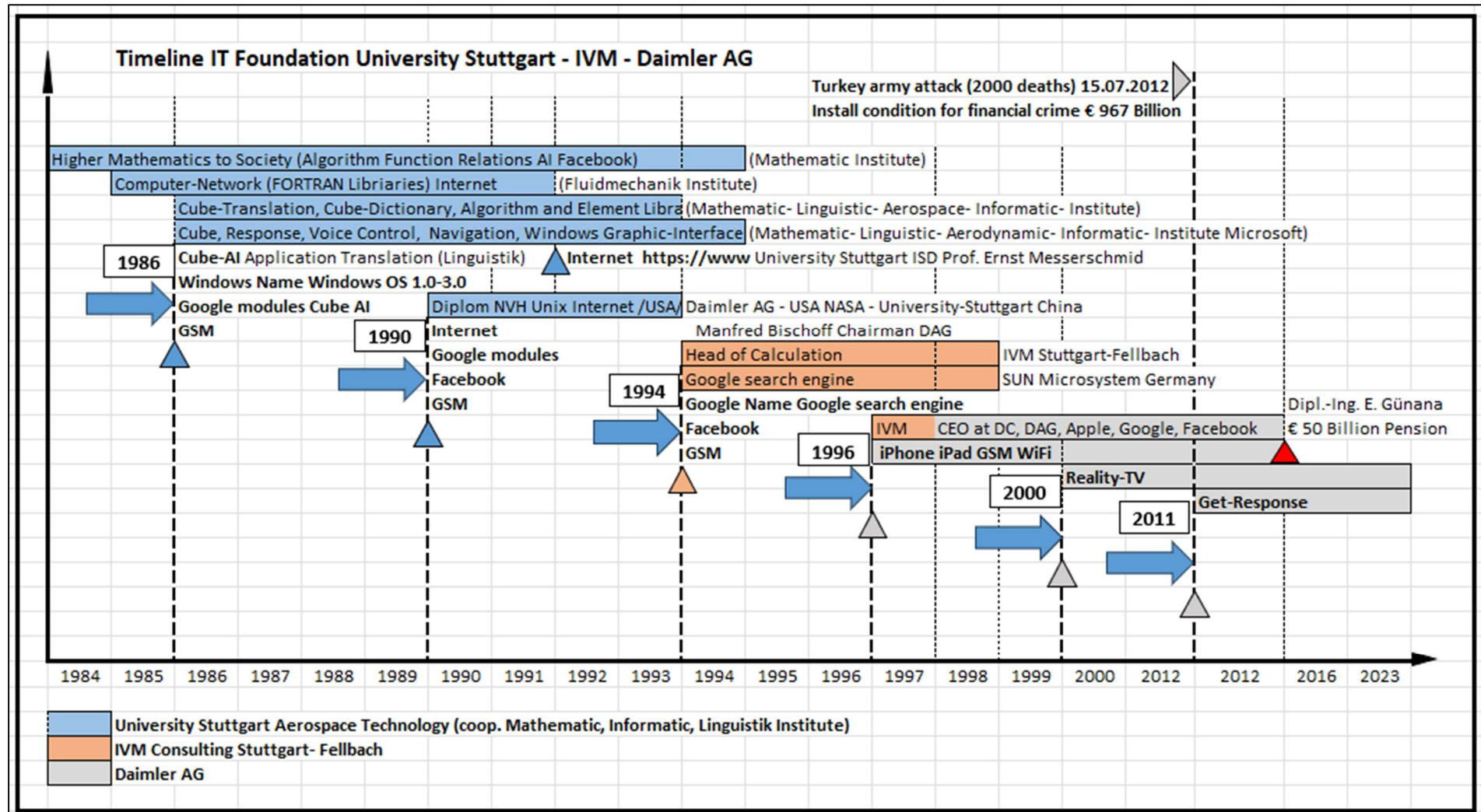


Chart 17: Milestones of IT Developments – AI, Cube, Internet, GSM, Windows, Google, iPhone, Wi-Fi, Facebook

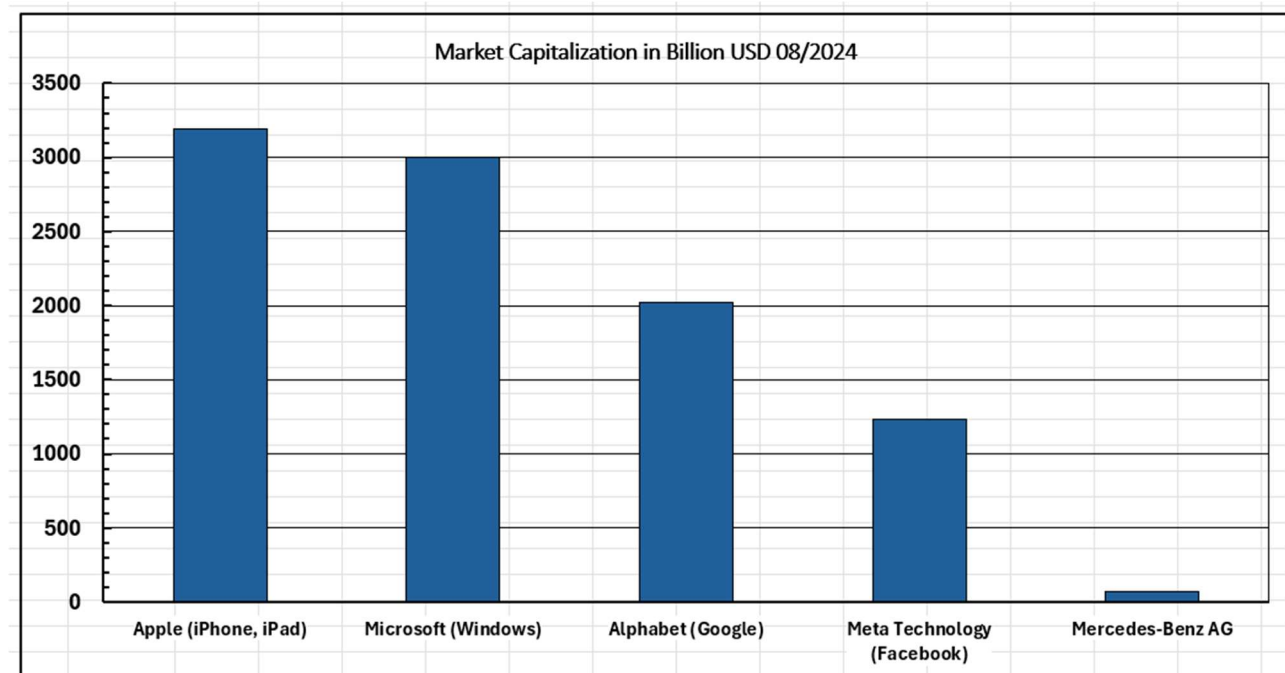


Chart 18 Benchmark market capitalization 2023

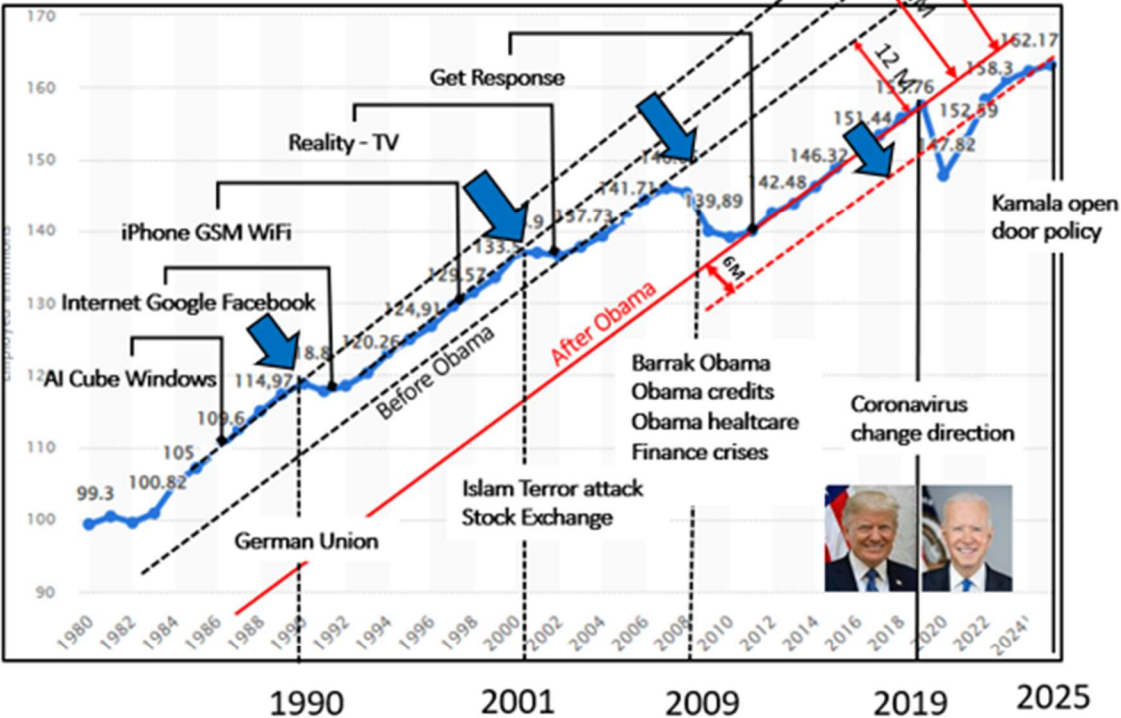

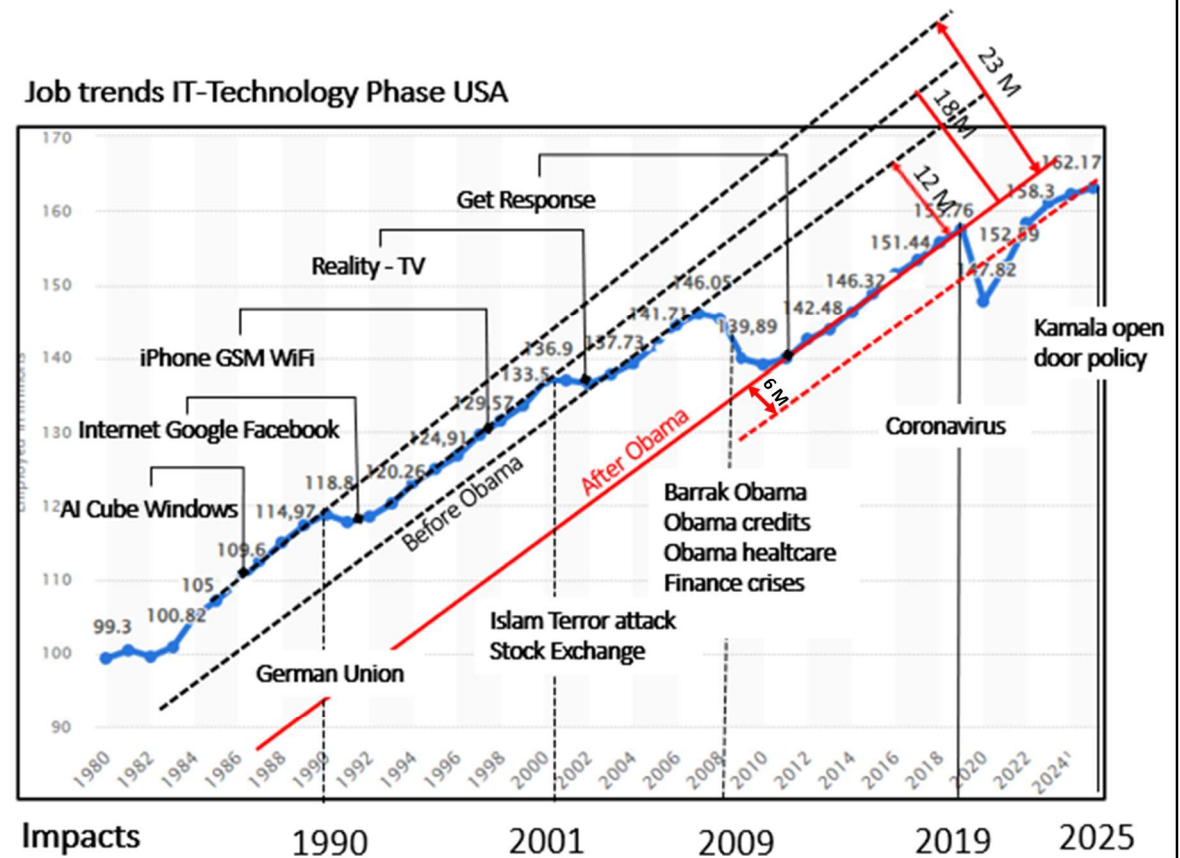

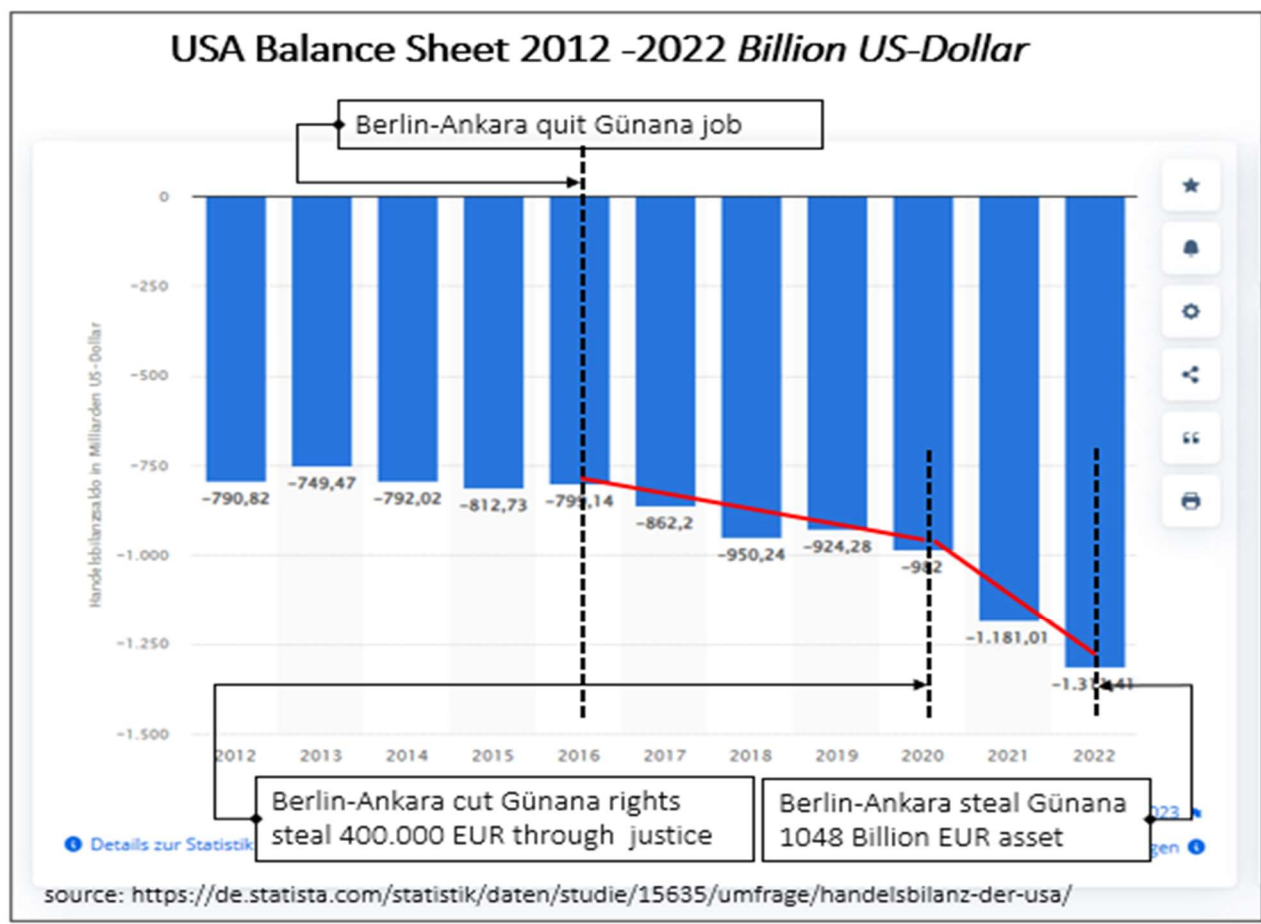

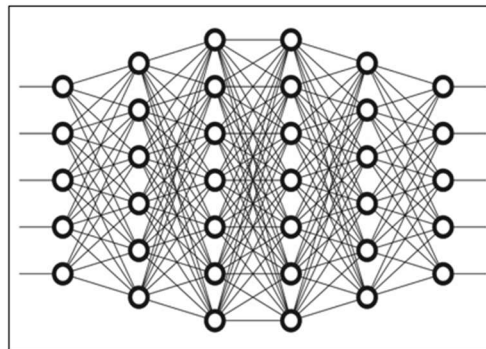

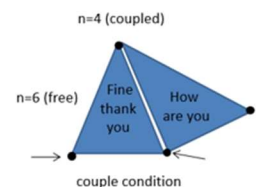


Chart 23: AI and Cube Theory and couple algorithm match to synapses and neural network

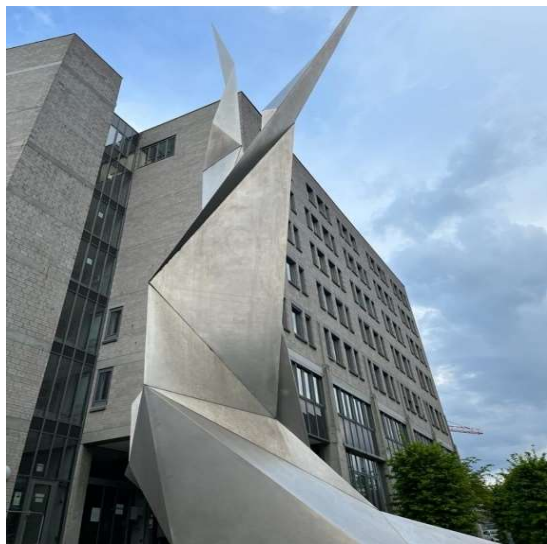


Chart 24: FEM Sculpture Stuttgart/Germany
